RE: **Township Appointments to District #10 PWIC**

I recently requested nominations for three individuals to serve as Township Representatives to the District #10 Public Works Integrating Committee (PWIC) which includes the counties of Butler, Clermont, Clinton, and Warren. District #10 is one of nineteen public works integrating committees responsible for recommending infrastructure projects to the Ohio Public Works Commission (OPWC) for funding. The membership of District #10 is defined by state statute in ORC section 164.04. Of the 24 members, there are "three members appointed by a majority of chief executive officers of all townships in the district". Meetings of the Integrating Committee are on the third Wednesday of each month in Lebanon, Ohio.

The terms of the **three (3) TOWNSHIP representatives** expired May 31, 2018. The current representatives are as follows:
